The Bureau of Land Management (BLM), Medford, Lakeview, and Northern California Districts are revising the current resource management plan (RMP) for the Cascade-Siskiyou National Monument (CSNM). This Proposed RMP/Final Environmental Impact Statement (Proposed RMP/Final EIS) provides a description of the various alternative management approaches the BLM is considering for the management of these lands along with an analysis of the potential effects of the alternatives and the Proposed RMP. The planning area is 170,407 acres and includes lands within Jackson and Klamath Counties in Oregon, and Siskiyou County in California. The CSNM's decision area is the approximately 113,500 acres of BLM-administered lands within the planning area. Approximately 5,340 acres of BLM-administered lands in the planning area are in Siskiyou County, California.
