Jared Riddle, the property owner, proposes the development of a two-story, 1,650 SF single-family residence with a 2,170 SF deck and a 923 SF carport on a vacant, 1.42-acre property zoned Residential Single Family (RSF-Z) located at 5205 Venado Avenue, Atascadero (APN 030-251-022). The proposed structure will have a maximum height of approximately 26'. The property will be served by the Atascadero Mutual Water Company and a proposed septic system. A proposed driveway connecting to Venado Avenue will provide access to the property. Earthwork for project will require 1,200 CY of cut, 1,200 CY of fill, retaining walls with a maximum height of approximately 13', and typical utility trenching. A total of (15) blue oak trees are proposed for removal.
