

**NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Single Family Residential development located on the northwest corner of Tamarisk Road and Huerta Street. APN No. 0482-031-01, -02, -07, and -08.

Project Description:	Tentative Tract Map (TTM No. 20489) to subdivide an approximately 10-acre parcel, described as Assessor's Parcel Number (APN) 0482-031-01, -02, -07, and -08 into 39 single-family residential lots and a retention basin.

This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act (CEQA).
