Conditional Use Permit for 3.1 acres of new mixed-light cannabis cultivation, and the development of ancillary structures for cultivation activities, including a 6,000 square-foot dry barn/nursery for drying, curing, and plant stock propagation, and a 1,280 square-foot commercial building for processing product grown on site, and Special Permit for project related wetland impacts, creation, and enhancement, and riparian enhancement associated with the realignment of a Class III ephemeral drainage.
