The Project will consist of a cannabis retail store located at 2721 South Grande Avenue, Santa Ana, CA 92705. The APN is 411-132-02. It will operate out of an existing building on a lot area of 14,221 square feet. It will occupy a floor space of approximately 8,629 square feet. The current and prior land use is commercial.

The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
