Project Title: HX Trinity Farm, LLC (Project)

Project Location: The Project is located at 3280 State Highway 3, Hayfork (APN 016-200-024-000) in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The proposed project consists of an existing cannabis cultivation operation located at 3280 State Highway 3, Hayfork (APN 016-200-024-000) in Trinity County. The project is on a 9.9-acre parcel zoned as Agricultural. The project consists of +/- 10,000 square feet (sf) of mature cannabis canopy and 1,440 sf of immature plant canopy. Plants are grown in 16 hoophouses which will be transitioned to greenhouse cultivation. Additional facilities include associated support buildings for pesticide and agricultural waste storage, harvest storage, processing and cannabis waste composting. Plastic tanks provide approximately 5,000 gallons of water storage. Water for this project is provided by an existing groundwater well. Wastewater is treated in an existing septic system. An existing residential unit is found on the property.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
