The California Department of Transportation (Caltrans) has issued a District Director’s Order to repair failed pavement on Interstate 80, from postmile 44.850 to R58.712, in Placer County. District pavement subject matter expert performed damage assessment and concluded multiple storm events beginning February 24, 2023, to March 28, 2023, and the heavy flow of truck traffic with chains have damaged the asphalt concrete pavement. Proposed scope of work includes site preparation, concrete grinding/slab replacement, striping, minor drainage work, traffic control, and incidental work.
