The California Department of Transportation (Caltrans) has issued a District Director's Order to construct a viaduct to address the failed pavement on Interstate 80, from postmile 0 to 16.5, in Nevada County. The proposed project plans to address damaged asphalt concrete by removing and replacing the storm damaged asphalt concrete pavement. Proposed scope of work includes site preparation, concrete grinding and polyester inlay, concrete slab replacement, striping, minor drainage work, traffic control, and incidental work.
