Project Title: Manzanita Land Holding, LLC (Project)

Project Location: The Project is located at 015-170-31-00 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The Project will consist of approximately 9,764.5sqft of mature canopy. Existing support infrastructure includes a 15"x15' composting area, a 4'x8' shed for petroleum storage, a 16'x40' building for processing, harvest storage, and agricultural chemical and pesticide storage, 84) 70" diameter pots for mature canopy (2,244.48sqft). a 5.000-gallon water storage tank, two (2) 2,500-gallon water storage tanks, and nine (9) 500-gallon nutrient mixing tanks and a permitted groundwater well.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
