Project Location: The Project is located at 270 Pine Forest Drive in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The Project will consist of up to 10,000 square feet (sf) of mature outdoor cannabis. Proposed activities include the cultivation of approximately 10,00 sf of mature outdoor cannabis, 1,000 sf immature plant area, support structures include a metal building approximately 400 sf for processing, 120 sf shed for harvest storage, and 64 sf storage area for pesticides and agriculture chemicals. The proposed project water source is a groundwater well.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
