We are unable to change the language in the Standard Permit Condition because it applies to all projects in the City. However, we will add the following Mitigation Measure to the Tribal Cultural Resources section of the CEQA document for this project:

**Mitigation Measure:** If tribal cultural resources are encountered during excavation and/or grading of the site, the Project Applicant shall notify the Tamien Nation Representative of the discovery.
