This project will replace pedestrian signal indicators at signals at various locations on State Routes 65, 137, 190 in Tulare County that have met or are approaching their end-of-life cycle on existing poles. Work includes replacing the existing pushbuttons and pedestrian signal heads with accessible pedestrian signal and LED count down signal heads. All work to occur in the Caltrans right of way.

Apply avoidance and/or minimization measure as required for nesting birds/night work. Pre-construction surveys for nesting migratory birds shall be required if vegetation removal work is done during the nesting bird season, February 15 to September 1. No trees shall be removed within the nesting season without prior approval by a Caltrans Biologist.

If previously unidentified cultural materials are unearthed during construction, work shall be halted in that area until a qualified archaeologist can assess the find.

Construction Standard Specification 14-11.15 shall be used to dispose of electrical equipment requiring special handling (if applicable to this project); Revised Standard Special Provision (RSSP) 87-21.03D will address the removal of electrical equipment designated as hazardous waste (if applicable to this project), use 2.9 of this provision to address the removal of existing equipment, as needed.
