Project Title: Enso Farms, LLC (Project)

Project Location: The Project is located at 12762 Cement Hill Rd in Nevada County.

County: Nevada County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Specialty Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project will consist of 5,000 square feet of mixed-light canopy located in two (2) 14-foot by 100-foot hoop houses and two (2) 22-foot by 100-foot hoop houses. There will be 2,575 square feet of support area for harvest storage, processing, hazardous material/pesticide and nutrient storage, and immature plant cultivation. The site is served by public water and a septic system for sewage disposal.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. On May 14, 2019, Nevada County Resolution No. 19-199 certified a Program Environmental Impact Report (PEIR; SCH #2018082023) for the Nevada County Commercial Cannabis Cultivation Ordinance. On January 10, 2023, the Nevada County Board of Supervisors adopted an Addendum to the certified PEIR which analyzed potential impacts associated with amendments to the Nevada County Commercial Cannabis Cultivation Ordinance. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
