Pacific Gas & Electric Company (PG&E) is updating the master plan for the existing PG&E San Carlos Service Center. The updated master plan proposes to replace the San Carlos Service Center's aged Fleet Maintenance and Shops buildings with new buildings for more efficient storage of PG&E materials, tools, and equipment; remodel the existing Operations building; provide environmental protection measures including stormwater runoff controls; protect buildings and materials storage areas from flood waters; install landscaping; replace and reconfigure existing parking lots and other hardscape areas; remove and reroute some existing utilities; install new utilities; install new light fixtures and signage; and install photovoltaic panels in the employee parking lot. The San Carlos Service Center serves large portions of San Mateo and Santa Clara counties and serves as the main hub for gas and electric utility service needs for the greater region.
