

HANDEL ROAD RESURFACING

Project Description

Project Location:

Handel Road: Alpine Road to eastern end. **See attached Vicinity Map.**

Project Justification:

The original construction date and existing roadway structure of Handel Road are unknown. The roadway is a two-lane 16 feet wide. The road has been periodically chip sealed with the most recent in 2014.

Existing pavement within the project location exhibits transverse and alligator cracking. There is also minor rutting.

Scope of Work:

The project will consist of:

1. Resurfacing existing roadway (16-foot-wide) with 0.25-foot Hot Mix Asphalt (HMA) (Type A).
2. Repairing pavement structure failure areas with full depth 0.25-foot HMA (Type A).
3. Paving 8-foot-wide driveways.
4. Replenishing 6-foot-wide gravel shoulders with specific slopes (2'/8% and 4'/conform).
5. Applying penetration treatment along curves and at all intersection radii plus 50 feet or to conform.
6. Adjusting existing survey monument frames and covers to finish grade.
7. Adjusting existing facilities to finish grade.

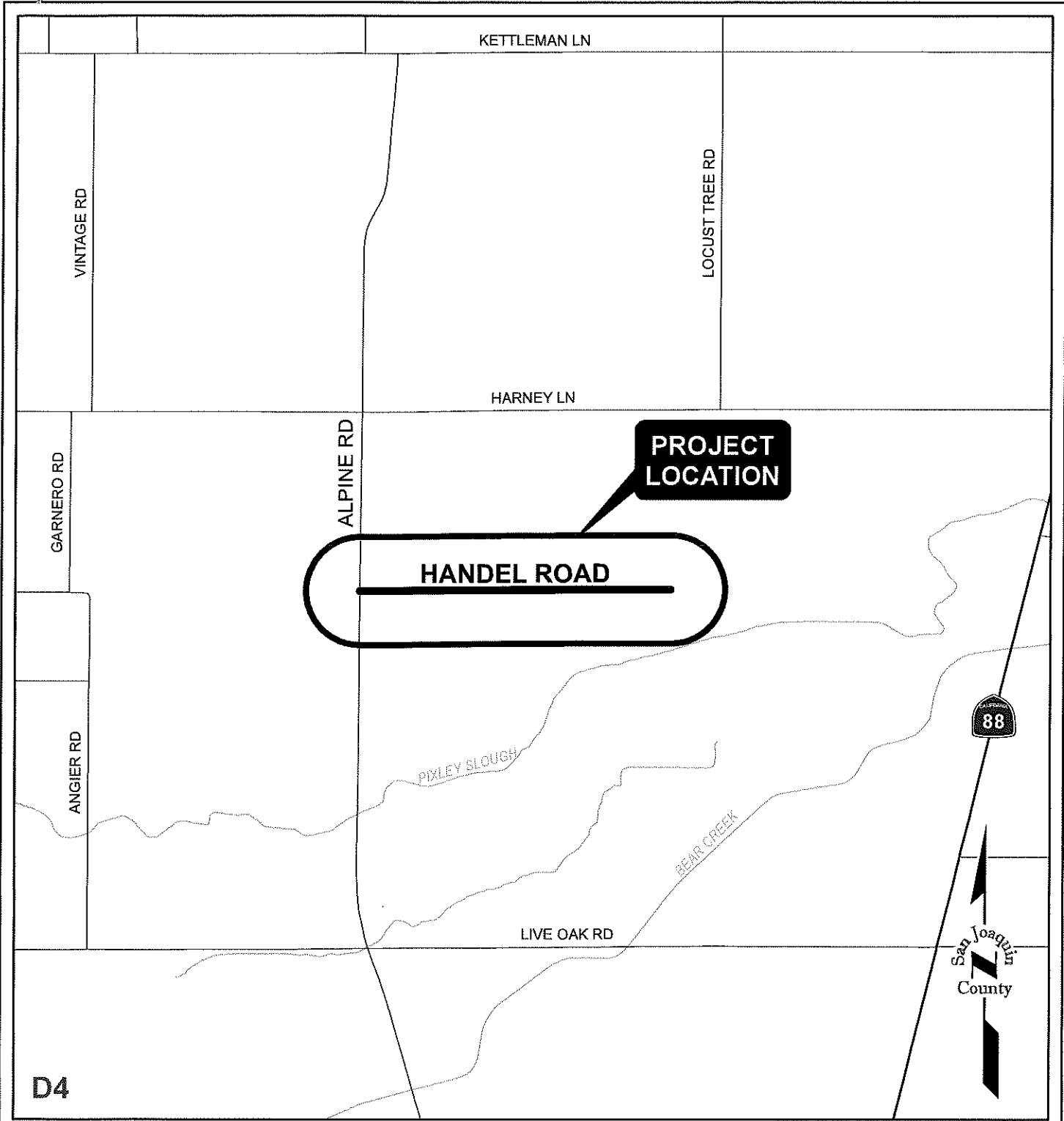
Environmental Setting:

In these portions of the San Joaquin County, land usage is primarily **rural with single family homes.**

There are many large trees adjacent to the project area. Nesting and migratory birds, protected by the Migratory Bird Treaty Act, may nest within these trees. Furthermore, the Swainson's Hawk, a raptor species of concern within the State of California and listed as threatened may nest adjacent to or within the project area. A pre-construction survey for nesting Swainson's Hawks and other migratory birds is recommended if construction is scheduled to occur from February 15th to September 1st.

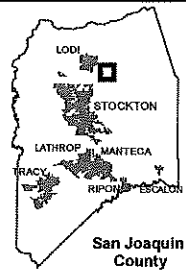
Beneficiaries:
