Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Retail and Distribution License submitted on 4/19/2018 and 12/6/2018 by MENDOCINO ORGANICS, LLC.

Project Activities:

The proposed project will operate a retail and distribution license out of an existing facility located at 13325 S HIGHWAY 101, HOPLAND, CA 95449 (APN 048-290-30-00). The applicant will store cannabis products for retail and distribution in 7,858 square foot facility. The project will not expand the existing facility and no modifications were needed prior to operation.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building facility with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
