The Colorado River Basin Water Board has determined that the Project is exempt from the procedural requirements of the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.; Cal. Code Regs., tit. 14, § 15000 et seq.; Cal. Code Regs., tit. 14, § 15061) under a Class 4 categorical exemption (Cal. Code Regs., tit. 14, § 15304 et seq.). Class 4 categorical exemptions consist of "minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes." The Colorado River Basin Water Board concludes that the enrollment of this Project and the activities described herein meet the exemption criteria under California Code of Regulations, title 14, section 15304 (Minor Alterations to Land) and no exceptions to the exemptions apply (Pub. Resources Code, § 21084; Cal. Code Regs., tit. 14, § 15300.2).
