Caltrans will rehabilitate ramp pavement at the westbound SR 78 onramp and offramps at Woodland Parkway. The work will include cold planing the top 0.20 feet of the existing asphalt concrete and replacing it with 0.20 feet of rubberized hot mix asphalt (RHMA) along the entire width of the ramp. Night work may be needed for lane and ramp closures. All work will occur within Caltrans right-of-way. The environmental commitments for visual resources, hazardous waste/materials, and NPDES/Stormwater are provided in the Environmental Commitments Record (ECR).
