Standard Coastal Development Permit to construct a driveway, a parking area for four vehicles, a 1,218 square foot single-family residence, install a culvert at the driveway approach, a septic system, replace a well pump, and implement a Mitigation Monitoring and Reporting Plan (MMRP). Additionally, the project anticipates temporarily installing a water tank, generator, and portable water pump for supplemental watering vegetation in proposed mitigation site. Pursuant to California Public Resources Code Section 4291, thirty feet of defensible space from the proposed development is required by the State of California Department of Forestry and Fire Protection Agency (CALFIRE) to act as a barrier to slow or halt the progress of fire. The proposed project includes clearing a total of 0.75± acre of vegetation for the building envelope.
