Reasons why project is exempt:	
The actions described herein are categorically exempt from the California Environmental Quality Act (CEQA) per CEQA Guidelines section 15320, which provides for a categorical exemption for changes in organization of local agencies, as well as the "common sense" exemption per CEQA Guidelines Section 15061(b)(3). This is because Public Resources Code section 15320 provides for a categorical exemption for changes in organization of local agencies that do not change the geographical area in which previously existing powers are exercised; here the Land is not provided water service and detachment will not change the exercise of existing District powers in that geographical area. In addition, CEQA's common sense exemption applies "[w]here it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment (CEQA Guidelines section 15061(b)(3).)
