

DYNASTY LANE AND FINE ROAD CULVERT PROJECT

Project Description

Project Location:

Fine Road: Between Milton Road and Dynasty Lane. **See attached Vicinity Map.**

Project Justification:

Fine Road has experienced some flooding due to new development in the region. The new development added new driveways off Fine Road and the pipes under the driveways were undersized causing water to back up and flood the corner of Fine Road and Dynasty Lane. The new dual 18-inch pipe culvert will allow storm water flows to get across Fine Road and reduce any future flooding issues.

Scope of Work:

The project will consist of:

1. Installing a dual 18-inch pipe culvert across Fine Road.

Environmental Setting:

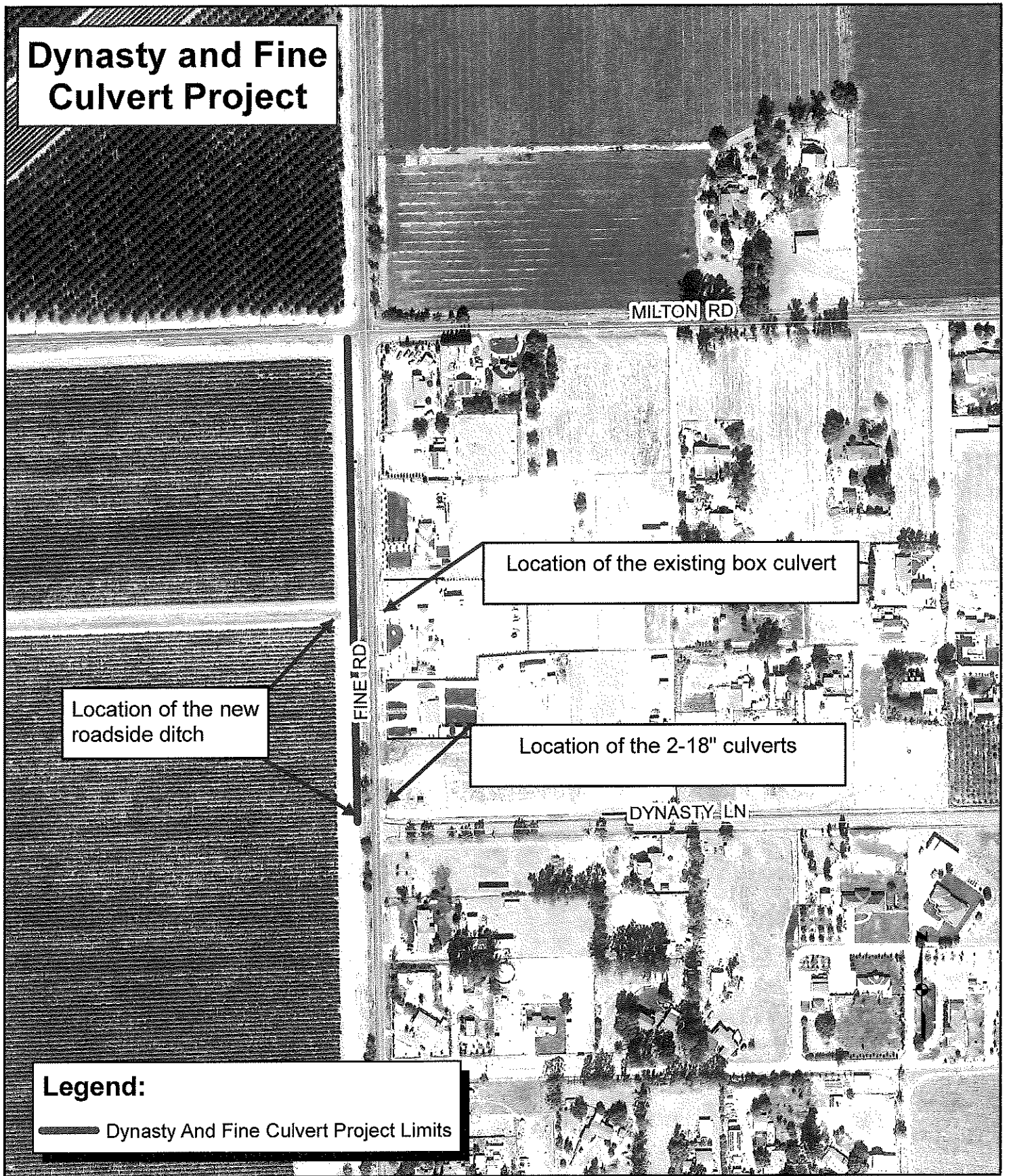
In these portions of the San Joaquin County, land usage is primarily **rural with single family homes.**

There are many large trees adjacent to the project area. Nesting and migratory birds, protected by the Migratory Bird Treaty Act, may nest within these trees. Furthermore, the Swainson's Hawk, a raptor species of concern within the State of California and listed as threatened may nest adjacent to or within the project area. A pre-construction survey for nesting Swainson's Hawks and other migratory birds is recommended if construction is scheduled to occur from February 15th to September 1st.

Beneficiaries:

The public will see a reduction in the risk of water pooling or flooding on roads and nearby properties. The culverts would improve drainage, making Fine Road safer during and after rain.
