The San Dieguito Union High School District (District) proposes a modernization of the Locker Room Building at Diegueno Middle School. The modernized facility would continue to support the existing Physical Education and Athletic programs at Diegueno Middle School, and the proposed scope of work includes new finishes throughout the interior including doors and hardware, new lockers, ADA compliant restrooms, All-Gender restroom facilities, ADA compliant showers, Title 24 compliant lighting, and new HVAC. The exterior scope includes updates to the existing shade structure between the existing Administration Building and the Locker-Room Building, new window treatments, doors and hardware improvements to the ADA path of travel from the parking lot to the Locker-Room building, replacement of the roof, and a new shade structure adjacent to the existing play courts.

Exempt Status: Categorical Exemption – Class 1, Existing Facilities CEQA Guidelines §15301; Class 4, *Minor Alterations to Land* (CEQA Guidelines §15304); and Class 14, *Minor Additions to Schools* (CEQA Guidelines §15314).

The Class 1 exemption applies as the proposed improvements would not result in the physical expansion of the Locker-Room Building, or alter the operation of Diegueno Middle School. The Class 4 exemption applies as all areas disturbed by the proposed improvements would be restored with pavement and/or landscaping. The Class 14 exemption applies as the new proposed shade structure would not increase teaching stations or enrollment capacity at Diegueno Middle School.
