### **Description of Nature, Purpose, and Beneficiaries of Project:**

The Sierra Nevada Conservancy would provide funding to the Mariposa Fire Safe Council to collaborate with local communities, local tribes, regional partners, and stakeholders to develop a priority plan to improve forest health and fire resiliency. The proposed activities will increase capacity to prioritize, develop, and identify potential future projects, not yet identified. Tasks conducted under these activities would include organization and staff development, facilitating and participating in training sessions, developing a long-term sustainability plan, attending regional conferences, working to develop monitoring and evaluation plans, communicating and engaging with stakeholders, facilitating meetings, and the gathering of pertinent data and information for plan development. The purpose is to engage with the local community, local tribes and stakeholders to identify and prioritize potential future forest health and fire resiliency projects, along with creating a project monitoring plan that could potentially lead to improved forest health and fire resiliency, facilitate greenhouse gas emissions reductions, and increase carbon sequestration.

### **Exempt Status:**

**Statutory Exemption:** Common Sense Exemption – CEQA Guidelines, Section 15061, subd. (b)(3) and Feasibility and Planning Studies under Pub. Resources Code, Section 21102 and CEQA Guidelines, Section 15262.

**Reasons why project is exempt:**

These activities are exempt under the commonsense exemption under Section 15061, subd. (b)(3) of the CEQA Guidelines which states that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. This grant funding will support capacity building activities including organization and staff development, facilitating and participating in trainings, attending workshops and conferences, and community engagement as well as the gathering and sharing of data for early-stage planning and prioritization of currently unidentified, potential future projects related to forest health and fire resiliency. The activities are early-stage planning activities; no specific projects have yet been identified, nor have they been approved, adopted, or funded. There will be no ground or resource disturbance. Therefore, it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment. Additionally, the project would be statutorily exempt under CEQA Guidelines, section 15262 exempting feasibility and planning studies as the activity involves planning studies for possible future actions which the Sierra Nevada Conservancy Board has not approved, adopted, or funded. Further, there is no legally binding effect on later activities.
