**Project Description**

Caltrans is proposing a culvert asset management project located along Interstate (I-15) at the Rainbow Glen undercrossing in the City of San Diego, San Diego County. Five (5) culverts from postmiles R52.54/ 52.78 were assessed and identified as needing repair to improve drainage capability. Work on these drainage assets will include cleaning, a pre-inspection via a remote operated camera and close circuit television to assess culvert condition and installing a resin-impregnated Cured-In-Place-Pipe (CIPP) liner to rehabilitate drainage assets. Environmental conditions are listed in the project's Environmental Commitments Record (ECR).
