The project consists of the following entitlement requests:

1. A Tentative Parcel Map to divide a vacant 15.6-acre lot into three new lots in the General Agricultural 5 (AG-5) zoning district.
2. A Design Review to determine substantial compliance with the Sacramento County Countywide Design Guidelines (Design Guidelines). The project is the division of the existing parcel into three separate parcels; the existing driveway will be abandoned, and a new driveway will be developed between Parcels 2 and 3, which will also connect Parcel 1 to Arno Road. Parcels will be served by separate wells and septic systems.
