Project Description

Project Title: San Timoteo Sanitary Landfill (STSL) Fencing Project.
Project Location: 31 Refuse Road, 2 miles south of Barton Road, off San Timoteo Canyon Road, in Redlands, San Bernardino County.
Project Description: The Solid Waste Management Division (SWMD) is proposing a fencing project around the site at the STSL located in the City of Redlands in San Bernardino County. This project consists of replacing and expanding the landfill's perimeter fence. A total of approximately 17,300 linear feet of wire-mesh fence is to be installed around the site per the layout shown in red on the enclosed Attachment 3. Currently, there is approximately 8,300 linear feet of existing operational fence installed within the site (shown in green on the enclosed Attachment 3). The interfering fence section between the existing operational fence alignment and the proposed fence alignment will be removed and replaced with the new proposed fence. The purpose of the fence is to keep the invasive donkeys off the site and protect the public by eliminating human/donkey interactions. This project necessitates the use of a truck and/or bobcat to deliver materials along the shown alignment. Manual-wheeled equipment will deliver materials in the farthest points. Equipment is expected to stay within the existing footprint. Equipment and materials will be delivered by pick-up truck or a small flatbed. The construction duration is anticipated to be up to twelve (12) weeks.
