
Reasons why project is exempt:

Improvements to existing facilities include wayfinding signage and informational kiosks, shade structures, high-visibility crosswalks, new pedestrian lighting, micromobility storage and bike/scooter share, new drought-tolerate shade trees, new furnishings, wifi, device-charging docs, restrooms and solar panels.
