Project Location: The Project is located at 2907 S. Halladay Ave., Santa Ana, CA 92705, in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 3/20/2024, by Edgar Gonzalez. Scanacart Enterprise, LLC, applied for a Manufacturing Type 6 Non-volatile Manufacturing License in an existing facility.

Project Activities:

The Project will occupy a facility with a total square footage of approximately 2,240 square feet and operate a Manufacturing Type 6 Non-volatile Manufacturing license with the following cannabis activities: non-volatile cannabis extractions using a Rosin press, infusions for filling cannabis vaporizers, and packaging and labelling the vaporizers. There are no exterior changes proposed for the building.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial multi-tenant building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
