<u>Project Description</u> Caltrans proposes a Minor B project to replace stand-alone irrigation controllers with the Regional Irrigation Control System (RCIS) Calsense platform at 12 various locations along I-805 within the County of San Diego. Project work will include removing and replacing the controller cabinets, removing and replacing the concrete pads the controller cabinets sit on, installing new master valves (RCVM) and flow sensors within the valve boxes, replacing the valve box covers, and trenching for and installing wires between the flow sensor in the valve controller boxes and the controller cabinets. This project will include ground disturbance and all work will occur within Caltrans Right-of-Way. Environmental Commitments are contained in the ECR.
