Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Medium Indoor license submitted on 04/22/2022 by Green Oho LLC.

Project Activities:

The project is located at 685 85th Avenue, Unit 5, Oakland (APN 042-4318-008-00) in Alameda County. Operations will consist of an indoor cannabis cultivation operation within an existing warehouse building on a 4.69-acre lot. The project includes up to 35794 sf of mature canopy and up to 932 sf of immature canopy. Associated functions include pesticide and agricultural chemical storage area, processing area, harvest storage area and cannabis waste area. No expansion of the building is planned.
