Project Title: Evergreen Mountain Ranch, LLC (Project)

Project Location: The Project is located at 71 Middle Court in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The Project will consist of up to 10,000 square feet (sf) of mature outdoor cannabis. Proposed activities include the cultivation of approximately 7,335 sf of mature outdoor cannabis, a 10'x20' area for post-harvest staging and drying, a 10'x12' structure for processing and agricultural storage, and a proposed 10'x12' area for harvest storage. The proposed project energy needs are supplied by a Honda generator and water source is provided by a permitted groundwater well.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
