The California Department of Transportation (Caltrans) initiated a District Director's Order for an Emergency Force Account project with the purpose of removing hazardous trees that sustained snow damage during recent storms along State Route (SR 32) at PM 1623 in Butte County. This project was needed to ensure that SR 32 would remain free of fallen trees throughout the season. Proposed scope of work includes site preparation, remove debris/trees, traffic control, and incidental work.
