Beyond Food Mart, Inc (Applicant) is requesting the approval of a Conditional Use Permit to construct and operate an 8-island fueling station, a 7,250 square-foot convenience store with a drive-thru for pre-packaged food pick-up, and a 1,673 square-foot drive-thru carwash. The 2.54-acre Project Site consists of two parcels (Assessor's Parcel No. 329-240-021 and 329-240-022) and is located at the northeast corner of Trumble Road and Ethanac Road in the City of Perris. Access to the site would be provided by a 40-foot-driveway at Trumble Road and a 40-foot-driveway at Ethanac Road.
