Approval of a Use Permit Major Modification to a fire-destroyed 20,000 gallon per year Pre-WDO winery to allow a new 12,051 sq. ft. winery facility, increased production to 30,000 gallons annually, increase employment, establish by appointment tours and tastings, establish a marketing program, addition of on-premise consumption, conversion of existing wine cave, change in internal circulation and installation of new process and domestic wastewater systems. The project also includes a Variance request to allow the new winery within the 600-foot winery setback.
