The project proposes the development of a commercial center on a 1.61-acre parcel at the intersection of West Frontage Road and Arc Way in central Ripon. The proposed development would consist of a Circle K convenience store building of approximately 5,198 square feet, along with six fuel dispensers under a canopy in front (east) of the store. The project also proposes full access of Frontage Road and more limited access off Arc Way. The project would require approval of a Major Site Plan Permit from the City.
