This is to advise that the County of San Diego Director of Department of Parks and Recreation has approved the above described project on **12/26/24** and found the project to be exempt from the CEQA under the following criteria:

Statement of reasons why project is exempt: The project is exempt from CEQA pursuant to Sections 15301, 15302 and 15304. Section 15301 and 15302 is applicable because the project is maintenance of existing landscaping and irrigation system at Waterfront Park Civic Green 6. Section 15304 is applicable because implementation of the project will require minor disturbance to land to remove the existing sod and topsoil, tilling of subsoil and trenching associated with replacement of the irrigation system.

Additionally, the project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code; and does not cause adverse change in the significance of a historical resource.
