**Description of Nature, Purpose, and Beneficiaries of Project:**

Caltrans is proposing a maintenance electrical project to reset the life cycle of Three (3) existing traffic signal systems that have reached its end of service life. This proposed project is located near State Route (SR) SR-98 at postmiles (PM) 31.303, 32.880 & SR-111 at PM R2.210 in Imperial County, California. Work would include replacing cables, controller cabinet, accessible pedestrian signal, and pedestrian signal head. Additionally, the installation of an intersection camera with performance measure will be included. Minimal soil disturbance will occur when installing a foundation for the controller cabinet.
