Project Description: The project is to repair the parking lot at the Sweetwater Little League Ballpark. Work includes milling and resurfacing of existing parking lot, replacement of broken curb and gutter, and regrading of drainage swale around the outside of the fields to direct flow towards existing catch basins.

This is to advise that the County of San Diego Director of Department of General Services has approved the above-described project on **December 24, 2024** and found the project to be exempt from the CEQA under the following criteria:

Activity is exempt from the CEQA because it is not a project as defined in Section 15378.

G 15061(b)(3) - It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment and the activity is not subject to the CEQA.

Statement of reasons why project is exempt: The project is exempt from CEQA pursuant to Sections 15301, 15302 and 15304 or the State CEQA Guidelines. Section 15301 is applicable because the project is repairs to an existing parking lot and drainage swales with no or negligible expansion of use. Section 15302 is applicable because the project is replacement of existing asphalt in the parking lot with no or negligible expansion of use. Section 15304 is applicable because minor grading will be required to smooth out the existing drainage swales adjacent to the ballfields.

Additionally, the project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code; and does not cause adverse change in the significance of a historical resource.
