The proposed project would connect the VWS to the City's public water system through installation of two parallel 8-inch diameter water pipelines (water pipelines) which would be buried a minimum of 4 feet in a 44-inch-wide trench within the Nash Road ROW. The 0.51-mile length of the water pipelines would connect to the existing distribution system at Rancho Valenzuela. The tanks, pumps and perimeter fencing of the original VWS at Rancho Valenzuela would be abandoned as a potable water source.
