The site's zoning is Manufacturing/Industrial (MI). The total land area of the project is 10.491 gross acres or 446,800 square feet and 10.004 net acres or 435,800 square feet. The site is currently vacant and partially disturbed. The proposed project consists of a subdivision of one lot into two and four buildings ranging between 44,100 and 45,000 square feet for a total of 178,200 square feet. Each building would contain 42,000 square feet for cultivation and 3,000 square feet of office space for Buildings 1 and 4 and 2,100 square feet of office space for Buildings 2 and 3.
