The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Retailer license submitted on 1/10/2018 by HT, Inc.

The Project will consist of cannabis retail operations at 38520 S Hwy 1, Gualala, CA, 95445 (APN 145-165-003-000). Activities will occur inside an existing 720 SF building on a 38,332 SF lot. The project site will be served by public utilities including power, water, and waste.
