Purpose and Need:

The purpose of the project is to bring the maintenance station within compliance of the required safety regulations. This project is needed to repair the damaged roof to avoid the loss or impairment of life, health, and property.

Environmental Commitments:

The following commitments are required to ensure environmental compliance on this project.

Hazardous Waste Specifications:

- An asbestos and lead paint survey are required before any work can take place.

Since construction of the proposed project cannot avoid disturbing the building, an asbestos and lead paint survey is required. This survey needs to be requested by the PE or PM and takes 2 to 5 months to complete since a task order has to be prepared, approved, and issued to a contractor. The contractor is then required to prepare work plans, health, and safety plans, conduct site investigations, and prepare site investigation reports for Caltrans review and approval.

Coordination:

Right-of-Way:

All staging occurred within Caltrans Right-of-Way.

Disposal/Borrow:

Based on the scope of work, there was no disposal that required a borrow site.

No Permits:

Based on the scope of work, regulatory permits were not required.

Consultation/Coordination:

Based on the scope of work and due to the nature of the project, formal consultation or coordination was not required.
