Project Location: The Project is located at 3535 GARRY AVE, SANTA ANA, CA 92704, in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution License submitted on 9/20/2021, by Greg Glogow. ORGANIC GROWTH VENTURES, INC applied for a distribution license out of an existing facility located at 3535 GARRY AVE, SANTA ANA, CA 92704 (APN 414-213-06). The applicant will store cannabis products for distribution in 1,161 square feet of a 19,205 square foot facility. Cultivation will also occur in a portion of the 19,205 square foot facility.

Project Activities:

The Project will consist of 19,205 square feet of distribution and cultivation activities. The project will not expand the existing facility and minor interior and exterior tenant modifications are proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
