Caltrans is proposing to install ADA accessible curb ramps and crosswalk striping at the intersections of Cole Rd/Blvd. and State Route 111 (SR-111) at postmile (PM) 2.211 in the City of Calexico, Imperial County. Work would include installing (3) sidewalks on Cole Rd/Blvd. to the extents of State R/W, installing (4) ADA Curb Ramps, installing (4) crosswalks with limit lines, adjust signal timing, & relocating loop detectors, ped push buttons, and removal of existing striping, as needed. Environmental conditions are listed in the project's Environmental Commitments Record (ECR).
