Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 5/29/2019, by Matteo Tabibzadeh. Se7enleaf, LLC applied for a Manufacturing Type 7 Volatile-solvent Extraction License in an existing facility.

Project Activities:

The project will conduct volatile-solvent manufacturing within a 4,360 square foot industrial building. The cannabis activities will include preparation, extraction, manufacturing, processing, packaging, staging, storage, and distribution. The project will improve an existing industrial building with only interior improvements and no changes beyond existing use proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for exterior changes or the addition of square footage. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
