Project Description

The California Department of Transportation (Caltrans) proposes to remove and crush stockpiled slide material, accumulated from the severe winter storms of 2023 and 2024, on State Routes (SR) 49 and 140 in Mariposa County. The project area spans from postmile (PM) 32.0 to 33.0 on SR-49 and PM 30.0 to 36.0 on SR-140. The purpose of this project is to remove the material and crush it to the required disposal size. The need for this project is to restore safe and efficient transportation along these vital corridors and prevent potential road closures, traffic delays and accidents.

General:

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact the Environmental Office if project changes occur or sensitive resources discovered.

Cultural:

- If cultural resources are discovered at the job site, do not disturb the resources and immediately:
 - Stop all work within a 60-ft radius discovery
 - Project the discovery area
 - Notify the Engineer
 - The department investigates. Do not move cultural materials or take them from the job site. Retain a qualified archaeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 stats that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

Hazardous Waste:

- Stockpiled slide material has the potential to contain asbestos containing rock, such as serpentine. Therefore, the stockpiles shall be sampled for Naturally Occurring Asbestos prior to crushing or transport.

No permits required for this project.
