The Project site, comprised of Assessor's Parcel Number (APN) 0490-091-09, is 304±-acres and configured in a roughly rectangular shape. The Project proposes the subdivision of the subject site into 23 parcels. The parcels are intended for individual sale and development as single-family residential properties. The proposed parcels range from 5 acres to 58.4 acres in size. The proposed tentative tract map (No. 20584) could, at maximum density, be built out to 23 single-family detached units.
