PROJECT TITLE: Floral Avenue Road Construction

Work Order# ZD40126C Task Code #Z1530

PROJECT SPONSOR: County of Riverside Transportation Department

PROJECT LOCATION: Community of Good Hope

PROJECT DESCRIPTION: The County of Riverside Transportation Department is proposing to construct approximately 2,000 feet of Floral Avenue from Read Street to Palm Street. Floral Avenue is not classified in the County of Riverside's General Plan. Floral Avenue is a dirt road of approximately 28 feet in width. The proposed project will include grading and moisture conditioning the roadway width and paving with Hot Mix Asphalt (HMA) concrete.

The proposed project will also include:

- Utility adjustments if needed
- Salvage/removal and installation of new signs

ENVIRONMENTAL ANALYSIS:

The proposed project will not acquire right-of-way.

This project is subject to compliance with the Western Riverside County MSHCP. In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside/inside of cell criteria area/conservation areas. This project is considered to be operation and maintenance; therefore, it is a covered activity under the Western Riverside County MSHCP.

If tree and/or vegetation removal takes place during the migratory bird breeding season (February 1 – September 1), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act.

The County of Riverside Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to construct approximately 2,000 feet of Floral Avenue from Read Street to Palm Street with Hot Mix Asphalt (HMA) concrete. The project in its entirety is consistent with Section 15301(c) because it does not create additional traffic lanes and involves no expansion of use of the existing roadway and associated facilities.
