Project Description

Caltrans is proposing a Minors project located east of Kenwood Drive along State Route (SR) SR-94 at postmile (PM) 11.827 in the City of Spring Valley, San Diego County, California. Work would include removing and replacing (R/R) a damaged slot drain, installing a secondary inlet connecting to the existing GCP inlet & R/R an existing asphalt apron with a 6'x 6' concrete apron around the two inlets. The existing guardrail will not be touched, and no trenching work will be done. Soil disturbance to the minimal extent feasible will occur and be only confined to the area where the proposed installation of the concrete pad and the removal of the slotted drain are proposed. Environmental conditions are listed in the project's Environmental Commitments Record (ECR).
