DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project is a request for a use permit to consolidate four outdoor cannabis cultivation zoning permit into one, one acre (43,560 square feet) outdoor cannabis operation within an existing fenced area located on a 45.72-acre parcel zoned LEA (Land Extensive Agriculture), with Combining Districts for F2 (Floodplain), Oak Woodland (OAK), RC50/25 (Riparian Corridor), Scenic Resources (SR) and VOH (Valley Oak Habitat); APN 128-444-002.

The proposed project consists of the continued operation of an existing outdoor cannabis site with minor expansion to add 3,560 square feet of canopy to the currently 40,000 square foot operation, as well as an additional 10,890 square feet area for accessory propagation and vegetative production. Existing infrastructure including fencing, irrigation lines, and access roads to remain unchanged. Deliveries are limited to 8:00am to 5:00pm Monday through Friday. Up to 2 full-time and 6 seasonal employees would serve the operation.

EXEMPT STATUS:

Categorical Exemption Section 15301(a) for Existing Facilities

REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the CEQA Guidelines pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15301(a) (Existing Facilities), as the continued operation of an existing outdoor cannabis cultivation operation with minor expansion of use. No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.

This Notice of Exemption is filed pursuant to the provisions of Section 15062 of the State CEQA Guidelines.
